2011 JANUARY-AUGUST UK TURKEY EXPORT IMPORT FIGURES

In the January-August the first eight-month cumulative period of 2011, UK exports to Turkey was up by 33.6%. Turkey's exports to UK increased by 20.3%:

JANUARY--AUGUST (Million \$)	2010	2011	Change
Turkey Exports to UK	4 397	5 290	20.3%
UK Exports to Turkey	2 867	3 829	33.6%
