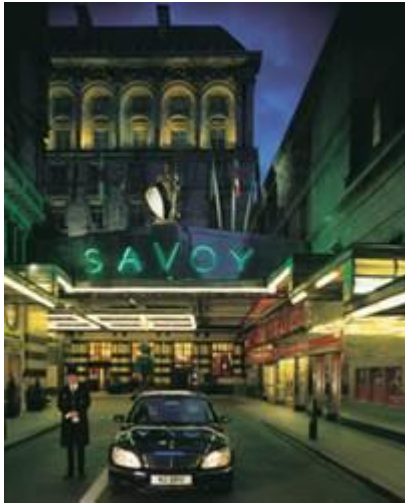

UK TURKEY TRADE DATA (January-May 2013)

UK Exports to Turkey: US\$ 2.5 billion, up by 9.5% compared to same period last year

Turkey Exports to UK: US\$ 3.3 billion, down by 4.4%
Total Trade (January-May 2013): US\$ 5.8 billion, up by 1.1%
Highest total annual trade was reached in year 2012: US\$ 14.3 billion.

NOTICE ON EXPORTING FISH AND FISHERY PRODUCTS TO TURKEY EXPORTERS REGISTRY FORM

The General Directorate of Imports of the Ministry of Economy of Turkey (T.C. Ekonomi Bakanlığı İthalat Genel Müdürlüğü) has announced that from 04.07.2013 companies exporting Fish and Fishery Products to Turkey must complete an 'Exporters Registry Form'. The application of the 'Exporters Registry Form, previously required only for the export of Textile and Ready Made Garments to Turkey is now extended to Fish and Fishery Products exports to Turkey. The Form must be completed for each different importer in Turkey. The related procedure:

- Submit the completed Form for TBCCI certification
- The certified Form will be legalised by the Turkish Consulate General in London
- The Exporter in the UK must send the certified and legalised form to each importer in Turkey

The [TBCCI Exporters Registry Form website](#) provides comprehensive guidance for the Exporters Registry Form procedure, including what the exporter in the UK must do, the Exporter Registry Form and TBCCI Certification and the Turkish Consulate Legalisation steps of the Form.
