UK TURKEY TRADE FIGURES JANUARY-APRIL 2016/15

In January-April the first four month period of 2016, Turkey Exports to the UK reached 3.9 billion US\$, and UK Exports to Turkey became 1.7 billion US\$. Compared to the same period in the previous year, the share of Turkey exports to the UK in the total of exports from Turkey rose from 7.6% to 8.4%, and the share of Turkey imports from the UK in the total of all Turkish imports increased from 2.5% to 2.8%.
